

### Details – D25/8

START at grid at end of bus stop lay-by on the south bound side of the A59 between Coe Lane traffic lights and Tarleton traffic lights. Proceed to Tarleton traffic lights where filter left to continue on A59 to the Hesketh Arms, Rufford. Turn **RIGHT** onto the B5246 and continue via Holmeswood to Mere Brow Traffic Island at the junction of the B5246/A565. Turn **LEFT** along A565 and continue via Banks Island to **PLOUGH ISLAND** where, **ENCIRCLE** island and retace along the A565 via Banks Island to Mere Brow Island. **ENCIRCLE** Mere Brow Island and **REPEAT** to Plough Island via Banks Island. Return on A565 via Banks Island to Mere Brow Island where turn **RIGHT** onto B5246. Retrace along B5246 via Holmeswood to junction with A59 at Hesketh Arms, Rufford. Turn **LEFT** on A59 and continue to finish opposite public footpath sign and stone gatepost at entrance to a field approx 20 yards before main route direction sign and 150 yards south of Tarleton traffic lights.

### Local regulations

The following local regulations have been approved by the CTT National Committee in accordance with Regulation 38. Any breaches may lead to disciplinary action being taken.

#### Local regulation No. 5

In all events, competitors prior to starting are not permitted to ride past the finish timekeeper during the duration of the event.

#### Local regulation No. 6

Any competitor making a 'U' turn in the vicinity of the start or finish will be disqualified from the event.

#### IN ADDITION TO THE ABOVE

Riders must give their number at the finish and elsewhere on the course if requested.

Riders must NOT stand in the road at the start or finish. (This constitutes obstruction, and is a breach of regulations).
